THE GREATER LONDON (RESTRICTION OF GOODS VEHICLES) TRAFFIC ORDER

(AMENDMENT NO. 9) ORDER 2009

Made: 16 December 2009

Coming in to operation: 1 January 2010

The London Councils Transport and Environment Committee (hereinafter called "the LC TEC") after consulting the Commissioner of Police of the City of London, the Commissioner of Police of the Metropolis, Transport for London, the Common Council of the City of London, and the Councils of the London boroughs and the City of Westminster, in exercise of the powers conferred by Sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and by Section 101(5) of the Local Government Act 1972 in respect of Transport for London, the Cities of London and Westminster and the London boroughs referred to in Schedule A to this Order ('the Authorities'), and in exercise of the functions delegated by those Authorities to the LC TEC and of all other powers thereunto enabling, hereby make the following Order:-

1. This Order shall come into operation on 1 January 2010 and may be cited as the Greater London (Restriction of Goods Vehicles) Traffic Order (Amendment No.9) Order 2009.
2. In this Order-
 - (i) "The Principal Order" means the Greater London (Restriction of Goods Vehicles) Traffic Order 1985 (as amended).
 - (ii) Save as set out in sub-paragraph (iii) all words in this Order have the same meaning as in the Principal Order.
 - (iii) Insofar as the Principal Order relates to the areas of the Authorities, the word 'Council' (meaning the former Greater London Council) means those Authorities in respect of their individual administrative areas.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Principal Order shall have effect as though it were amended as follows:-

- (i) The definition of "Permit" in Article 2(1) thereof were deleted and substituted by the following:

"Permission" means a permission granted by or on behalf of the Council under the provisions of Articles 5 or 6 hereof which exempts a vehicle from the prohibition imposed by this Order;"

- (ii) The references to "issue of permits" and "issue of a permit" in Article 2(2) thereof were deleted and substituted by "granting of permissions" and "grant of a permission" respectively;

- (iii) The reference to "permit has been issued" in Article 4(a) thereof were deleted and substituted by "permission has been granted";

- (iv) Article 4(a)(i) thereof were deleted;

- (v) The reference to "permit is issued" in Article 4(a)(ii) thereof were deleted and substituted by "permission is granted";

- (vi) The references to "issue a permit" and "16.5 tonnes" in Article 5 were deleted and substituted by "grant a permission" and "18 tonnes" respectively;

- (vii) The reference to "issue of a permit" in Article 6(1) thereof were deleted and substituted by "grant of a permission";

- (viii) Article 6(2) thereof were deleted and substituted by the following:

"On receipt of an application duly made under this provision the Council, upon being satisfied that a permission should be granted to the applicant, shall record that permission and notify the applicant accordingly.";

- (ix) Article 6(3) thereof were deleted and substituted by the following:

"The notification referred to in Article 6(2) above shall be a written schedule in such form as may from time to time be prescribed by the Council and shall include the following:-

- (a) the registration mark of the vehicle in respect of which the permission has been granted;
 - (b) the duration of the permission and an expiry date;
 - (c) the conditions to which the permission is subject.";
- (x) The references to "permit has been issued" and "issue of the permit" in Article 6(4) thereof were deleted and substituted by "permission has been granted" and "grant of the permission" respectively;

- (xi) The references to "permit" in Article 6(4)(a) to (d) thereof were deleted and substituted by "permission";
- (xii) In Article 6(4)(c) thereof the wording after "revoked" were deleted;
- (xiii) Article 6(5) to (7) thereof were deleted;
- (xiv) The reference to "issue a permit" in Article 7 thereof were deleted and substituted by "grant a permission".

4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Principal Order shall further have effect as though Part B of the Schedule were amended as follows-



EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order further amends the Greater London (Restriction of Goods Vehicles) Traffic Order 1985 so that Authorities are no longer required to issue physical permits to exempt vehicles from the prohibition imposed by the Principal Order, and drivers are no longer required to display such permits in their vehicles. The process for obtaining such an exemption remains unchanged. The Order also contains a drafting amendment and makes extensive changes to the Excluded Road Network as set out in the Schedule to the Principal Order.
